Join the NMMA and the US Commercial Service for a week-long fact finding mission to learn firsthand about the growing boating market in the Iberian region. During this trip, we'll explore potential business opportunities and growth areas for our industry in key areas of Portugal. We will also focus on gathering information on new projects, new contacts and new opportunities, in addition to networking with industry stakeholders and potential customers.

We'll then hop over to Barcelona, Spain to benefit from a full day at the Barcelona International Boat Show. This leg of the trip will feature a tour of the prestigious marina MB92 and a networking cocktail event with industry leaders.

#### Why Portugal?

Portugal is renowned for its rich historical navigation tradition that dates back to the 15<sup>th</sup> century. Interest in recreational boating, while modest is growing. However, with nearly 1,000 km of beautiful coastline, as well as inland waterways including river estuaries, Portugal is a boating paradise with year-round boating and considerable potential.

Portugal has a politically stable environment with a democratically elected government and is welcoming of foreign business and investment. A member of the European Union (EU) and the euro zone, Portugal is fully integrated with the EU, uses the euro currency, and follows directives from the European Commission in Brussels. As with all EU countries, Portugal's borders and ports are completely open to the free flow of trade with other EU member countries.

The United States is Portugal's largest trading partner outside the European Union. The total value of U.S. goods sold into Portugal is undoubtedly higher than the statistics reflect, as census data does not account for U.S. products imported into other EU countries and subsequently transported into Portugal for sale. (It is common throughout the European Union for goods to be shipped to one EU location—often to take advantage of lower value added tax rates—and then to be distributed by ground transport to neighboring member state markets.)
