Without such proof, application for NMMA membership will not be considered by any propulsion manufacturing firm outside North America.

AMD applicants outside North America must demonstrate that they have obtained a certificate of authority from one state of the United States which shows that they are legally authorized to conduct business in that state, thereby submitting to its jurisdiction. Without proof of this certificate of authority your application for NMMA membership will not be considered.
